Please note that this job description is indicative of the nature and level of responsibilities associated with this role and is not intended to be exhaustive.

ROLE OVERVIEW

The GIS Analyst is responsible for supporting SFRS future scenario planning and risk analysis across Scotland's communities, as well as a wider portfolio of service transformation projects including the Service Delivery Model Programme (SDMP).

Reporting into the Strategic Analyst, the post holder will apply highly developed knowledge of GIS to generate and promote a wide range of strategic insights and locational intelligence in support of the Community Risk Index Model (CRIM) and the wider programme of SDMP projects, ensuring timing and quality standards are met across all activities.

The post holder will work collaboratively with and provide advice and guidance to the GIS Officer and a range of key stakeholders, supporting all geospatial analysis as well as building and testing models to ensure that the team are able to effectively identify where SFRS can deliver a balanced prevention, protection and response service in line with the objectives of the SDMP and the wider Service needs.

KEY FUNCTIONAL RESPONSIBILITIES

- 1. Design, build, render & analyse mapping output using ArcGIS Pro, ArcGIS Online, ESRI extensions & applications for the purpose of generating a wide range of strategic insights & locational intelligence for CRIM and SDMP projects
- 2. Assemble spatial evidence (e.g. temporal, statistical, proximity, overlay, network & 3D), conduct spatial analysis and develop spatial solutions for SDMP/SFRS projects & reports using the full range of ArcGIS applications
- 3. Build, develop & deploy interactive Web Maps, Web Layers, Story Maps etc on the cloud-based ArcGIS Online platform and generate web apps using ESRI Web AppBuilder, AppStudio, ArcGIS Experience Builder and other supporting ESRI apps
- 4. Maintain, develop and extend SDMP library of hosted feature layers and other spatial content on ArcGIS Online and prepare Web Apps, feature layers, dashboards etc for sharing across SFRS
- 5. Conduct locational, thematic, hot spot and drive time analysis where necessary building appropriate geoprocessing models & tools using ArcGIS Pro ModelBuilder where required within projects

- 6. Assist with spatial statistics including descriptive, inferential & regression analysis, as well as cluster, raster, interpolation, autocorrelation, locational & suitability modelling to support the development of a range of 'What-if' scenario tests in support of SDMP projects
- Create, manage and maintain the SDMP suite of geodatabases supporting the Community Risk Index Model, ensuring all SDMP sourced or supplied raw datasets are 'fit for purpose' - verified, secured, transformed, tabulated, de-bugged, formatted and geocoded to acceptable standards (e.g. OGC)¹ for continuous use by the SDMP Project Team.
- 8. Maintain data integrity, metadata & data disclosure standards across all SDMP file geodatabases with regular GIS updates, cleansing, recoding, editing, back-up and troubleshooting resolving GIS data problems as they arise in support of all project work, and ensuring compliance with data security legislation and internal ICT policy and process.
- 9. Integrate data from geospatial, demographic, socio-economic, physical, environmental and geodemographic datasets to support CRIM, while assessing value and reliability of new data & feature classes where appropriate, making recommendations as to their usefulness to wider SDMP tasks and projects.
- 10. Explore and establish alternative sources of potentially viable geospatial data where necessary for the CRIM 2² project, including structured and unstructured datasets, verifiable open source data, central & local government sources, academic, partner & other official agencies
- 11. Liaise internally with the GIS Officer, ICT Services and externally with ESRI Technical Services as appropriate to resolve GIS desk application and AGOL issues where they arise, to ensure project deadlines are met.
- 12. Work collaboratively within the SDMP Team, while developing and maintaining effective working relationships with all SFRS colleagues & partner agencies to share and promote location-based intelligence & insights across the organisation
- 13. Visualise, explain and communicate spatial statistics and GIS findings in accessible layman terms to a wide range of audiences including internal and external stakeholders.
- 14. Liaise with ICT on the Public Sector Geospatial Agreement (PSGA) where necessary, maintaining awareness of updates including addressing and UPRN integrity using the SFRS Gazetteer to ensure quality and data integrity standards are met.
- 15. Maintain awareness of all developments in the ESRI ArcGIS suite of applications, Ordnance Survey Data Hub and GIS analytical procedures, while maximising use of ESRI UK eLearning modules to acquire new skills in latest ArcGIS applications & techniques (e.g. spatial analysis, web apps, map editing, location analytics, python scripting, 3D data visualisation etc.)

- Degree-level qualification in a numerate discipline, ideally with a major component of geographic analysis, or equivalent experience gained in a working environment
- A highly developed knowledge of GIS (preferably ArcGIS desktop products & apps) with significant experience in one or more ESRI desktop map authoring packages e.g. ArcGIS Pro (version 2.1 onwards) or ArcMap (versions 10.7 onwards)
- Experience of building web mapping applications using cloud-based platforms such as ArcGIS Online, Google Maps, Carto, Mapbox etc
- Proven experience of quantitative analysis and manipulating large and complex datasets using spreadsheets such as Excel
- Excellent problem-solving skills
- Receptive to learning, adapting and applying solutions using new GIS applications, technology and techniques
- Strong communication skills with experience in presenting complex issues in a tailored way to a wide range of audiences

- Ability to work on own initiative and exercise judgement based on analysis of datasets
- Ability to work as part of a small team of staff to achieve common departmental goals

Desirable Criteria

- Experience in multiple ESRI desktop extension such as Spatial Analyst, Network Analyst or 3D Analyst
- Basic skills in the Python programming language, ideally with proven application in GIS models, workflows and geoprocessing environments.
- Experience of scripting SQL, JavaScript, Java, C++, C#, Matlab etc for GIS workflows or solutions
- Knowledge of the R statistical programming language using R Studio and application of regression techniques
- Knowledge of a wide range of statistical methods and experience of applying these in practice
- Experience of other GIS packages (e.g. QGIS, Mapinfo, Cadcorp SIS, Leaflet for R, Google Maps API, Maptitude etc)
- Demonstrable experience in managing small teams to deliver projects within timescales and resources

HOURS OF WORK

This is a full-time post however applications from individuals seeking to work on a part time, job share or flexible working basis would be considered.

The standard working week for support staff posts is 35 hours.

The standard work pattern for support staff is as follows;

Monday – Thursday	0845 – 1645
Friday	0845 – 1530

There is a 45-minute unpaid lunch per day.

In order to maintain service delivery until 1645 on Fridays, your work pattern may be adjusted locally to provide this cover within your Directorate or Section. This arrangement is based on any rota applicable within your workplace.

<u>PAY</u>

The salary range for this role is £35,313 - £38,940.

Salary on appointment will normally be on the bottom point of the salary scale, with progression subject to regular review in line with the SFRS performance appraisal arrangements. A higher salary placing will be considered in exceptional circumstances subject to experience demonstrated.

Your salary will be paid monthly, directly into your bank account. Salaries are paid on the second last day of each calendar month unless this falls on the weekend, in which case it will be paid on the Friday.

PENSION

This post is pensionable.

Her Majesty's Revenue & Customs have set limits on the tax relief on your pension. Where your pension entitlements increase and these exceed the tax relief limits set, you will have to pay tax on the excess. There are two thresholds to be aware of. One of which is known as the Annual Allowance (AA) which permits a maximum increase in the value of your pension in a given year. The other is the Lifetime Allowance (LTA) which limits the total value of your overall pension pot. If either of these thresholds is breached, this may lead to an increased tax liability.

Applicants seeking promotion should therefore recognise the potential for any substantial increase in pensionable pay to result in an additional tax liability.

The calculation of your pension pot is subject to a complex calculation that allows for factors specific to each employee to be taken into consideration. It is therefore not possible, or appropriate, for SFRS

to issue you with advice on this. All applicants are advised to take the effects of the AA or the LTA into consideration when applying for promotion.

ANNUAL LEAVE

The standard annual leave entitlement for full time employees (working over 5 days) is 26 days per annum, rising to 32 days after five years continuous service.

THE SELECTION PROCESS

ONLINE APPLICATION

Please ensure that you complete the on-line application as fully as you can. It is important that you demonstrate how you meet the essential and desirable criteria outlined within the Job Description.

SHORTLISTING

The SFRS evaluate candidate suitability for a role by assessing your knowledge, experience and skills in relation to the criteria for the role and the Personal Qualities and Attributes (PQAs) detailed within the Job Description.

You need to be clear and specific about your skills and experience as only the most suitable applicants will be selected for interview based on the evidence provided in the application.

ROLE SPECIFIC ASSESSMENT

The SFRS endeavor to identify and select the best candidate for each role and use assessment tools e.g. Psychometric tests or practical exercises such as presentations or a written exercise, to offer further objective information about a candidates' abilities in relation to the role applied for.

The tests give a measure of your strengths/limitations. Research has shown that people who do well in these tests go on to do well in the job itself.

INTERVIEW

PQAs measure the underlying attitudes and behaviours upon which good performance lies. To ensure you are in the best position to perform to your highest standards during our selection process, make sure you review the PQAs outlined in the Job Description, and have prepared examples of times you have successfully demonstrated these behaviours in the past. PQAs are sometimes referred to as 'competencies': for tips on how to prepare you may wish to conduct an internet search e.g. "preparing for a competency-based interview".

OFFER

If successful we will issue an offer of appointment. The offer of appointment will be conditional and subject to the following pre-employment checks: -

\rightarrow Confirmation of Right to Work in the UK

In line with the Immigration, Asylum & Nationality Act 2006, all candidates applying for SFRS roles must be eligible to live and work in the UK. Documented evidence of eligibility will be requested from candidates as part of the selection process and will require to be checked and verified.

\rightarrow Medical

Candidates are either requested to attend a pre-employment medical examination or complete a preemployment medical questionnaire; both are subject to approval from our Health and Wellbeing Team. We expect high levels of attendance from our employees. As part of the medical process we ask you to provide details of your attendance at work in the previous year. Absences of more than 10 working days may be investigated further with due consideration given to the timescales and reasons for these absences.

\rightarrow Receipt of satisfactory references.

When completing the application form, you will be asked to include details of two referees. We recommend that you obtain the approval of any individual whose details you input into this section. If we do not receive references timeously this may affect your start date and appointment with the SFRS.

The referees should be two individuals who have known you for at least 12 months and who know you in a work capacity or can comment on your ability to carry out the role applied for. At least one of these should be from your current employer, where possible, providing you have been employed with them for a period of at least 12 months prior to submitting your application. The referees should not be related to you in any way.

Referees will not be contacted unless a formal Offer of Employment is made.

\rightarrow Criminal Record Check

Dependent on the nature of the post, it may be necessary to undertake a criminal record check. This may be a standard, enhanced or PVG disclosure. The SFRS will pay the required fees associated with the criminal record check.
